Swans:

Sadly we have to report the death of one of our swans. As reported before, we had a very aggressive swan on our lake. Our swan became aggressive due to the torment it received from wave runners and boats.

Our swan collided with a wave runner this past weekend. Upon collision the swan broke it's neck and died. Now this incident was an accident, so no one was prosecuted. If it had been an intentional act of harassment the driver would have been prosecuted. The sentence could have been a huge fine and six months in jail.

People must understand that our wildlife is important!! The swan's only defense is to attack when tormented or threatened. Please use common sense and leave the wild life alone.

DOCKS:

Norma Taylor notified Steve Pritchard, President of the Association, that the DEQ requires a "*marina permit*" for the docks located in our "common" areas.

Upon further investigation, it was agreed that the association would apply for the permit, which has been done.

We have one step left in our marina permit application. New dock regulations will be published soon.

Last year the fireworks were almost canceled because people were shooting fireworks over the island where all the fireworks are stored and setup prior to the show.

Boat traffic must go counterclockwise.

You must have a spotter when towing! Wave runner spotters must face backwards!!

Please keep 100 feet from docks, boats and wildlife!

All watercrafts must have an association sticker.

No visitor boats allowed!

ATV's:

Remember ATV's are not allowed on county roads. Dirt bikes are not allowed to run over the berm. It is fenced off and signs are posted. **If you are the guilty one, please stop!**
