# Information to LSA Members *Dues*

In accordance with past practices and the requirements of our Association By-laws, the Board of Directors has issued "Dues Statements" for the annual dues which are due and payable on or before April 1.

As we all know, there have been three dues increase initiatives in the past year and a half. None of them were successful. Thus, the Association must control its expenses to coincide with the available revenues from the current \$150.00 annual dues amount.

Inasmuch as the last dues increase vote was favored by far more than half of those voting (failing to meet the 2/3's requirement by 3 votes) AND it is not practical to initiate another dues increase vote prior to April 1, the Board of Directors have designed the April 1 Dues Statements to provide a provision for any member wishing to make a voluntary contribution to be able to do so and to designate a specific purpose or use of their gift.

We encourage you to look closely at your Dues Statement, when it arrives, and to seriously consider paying the proposed (but defeated) dues increase amount of \$195.00 ■

June 15, 2015, Last day to file an application for candidacy. June 27, 2015, "Meet the Candidates" meeting at the pavilion.

July 01, 2015, Mail out the ballots.

August 01, 2015, Last day for ballots to be received. (Can be dropped off at the Pavilion between 10:00 AM and 12 Noon.

August 08, 2015, Annual Meeting, and meet the New Board of Directors.

## Law Suit Update

Your LSA Board of Directors is pleased to inform you that on January 23, 2015 the Honorable Suzanne Kreeger, Judge of the Circuit Court for Montcalm County signed the "Judgment following Placement of Settlement Terms on the Record June 24, 2014." This signing by the Judge comes after nearly six months of work between the attorneys for the Plaintiffs and the Defendants working thru the details of the "Global Agreement" that was put on record with the court on June 24 of last year. On February 25, 2015 the Board welcomed Darrin Bernatowicz as an appointed Director to serve the balance of Susan's term. Darrin ran for a Board seat in the last annual election and received the 6th most votes. (The top five were the elected Board). Darrin is a 16 year resident of Indian Lake and resides at 17080 Winona Lane.
