Fireworks in Jeopardy:

As the signs at the entrance to Indian Lake report, the contributions that have been given so far this spring for our July 3rd fireworks show have fallen far short of the \$6000 that is needed. Our treasurer has indicated that as of Monday, April 23 she had received only \$2500 in donations. The deadline for contributions to reach the \$6000 mark is June 3.

Monthly LSA Board Meeting:

The monthly LSA Board meetings are scheduled for the 1st Monday of the month at 6:30 pm in the pavilion. Please come and share your ideas! Also see the President's report on page 6.

Indian Lakes Boating Regulations:

- 1. There shall be no high speed boating/jet skiing or in other words no wake for the entire lake before 11:00 am and after 8:30 pm.
- 2. When any watercraft has a person or persons in tow in any fashion, a spotter must be present on the tow-craft as proscribed by Michigan law.
- 3. All watercraft must stay a minimum distance of 100 feet from all other boats and objects as proscribed by Michigan law.
- 4. All traffic must be going in a counter-clockwise fashion around the lake.
- 5. The launch is for association members only. Only watercraft with appropriate stickers will be allowed on this lake.
- 6. The appropriate stickers must be applied to all trailers at the boat launch.
- 7. Absolutely no visiting watercraft are permitted on our lake.

These rules have been established for the safety of all members and will be enforced.

Pavilion:

PAVILION

The use of the pavilion is gaining in popularity. There is a flat \$50 rental fee plus a \$50 cleaning deposit for the use of the pavilion. This rental fee was established based on the member vote at the annual meeting in August 2008. Dues must be current for members to able to rent the pavilion. The pavilion can be reserved for your personal event by contacting Tammy Williams at 231-629-1877.

Also please note that the cleaning deposit will be forfeited if fasteners such as tape, nails, wires, paperclips, and screws are used to attach items to walls, ceiling, or windows. Smoking is not allowed in the pavilion – smoking in the pavilion will also result in the forfeiture of the cleaning fee.

Fish:

The board encourages all fishermen to practice the custom of catch and release.

We hear that there was a 15" walleye caught and released along with a nice crappie. So our plantings are showing signs of success.

Fireworks:

The fireworks show this summer will be held on Sunday, July 3 **if we receive enough donations to fund it**. There will be a meeting at the Pavilion on May 23 at 6:30 pm to organize door to door canvassers to get donations for our fireworks. We are looking for people who can canvass sometime during the Memorial holiday weekend.

Please note: donations for our fireworks must be in by June 3rd.

Dumpsters:



There will be yard waste dumpsters (no rubbish, trees, plastic or liquids) available starting May 14 and for a short time again this this fall. The fall dates will be published later this summer. These dumpsters will be located at the same two locations as last fall – Tall Oaks and Pawnee Points parks.

Weeds:

PLM – Lake & Land management Corporation will continue to provide aquatic management of our lake in 2011. The estimated budget for 2011 is between \$7,500 and \$15,000. Please see page 6 for the 2011 lake treatment schedule, and page 7 on how you can help prevent the invasion of aquatic nuisance species of plants and animals into our lake.

Building Regulations:

Building regulations are spelled out in LSA covenants, restrictions and township zoning ordnance. All structures and alterations must get approval and/or permits from LSA. architectural board, township zoning administrator, and county building department. Reminder: **You are not allowed to have any sheds on vacant lots.**

The first step in any building process is to contact the architectural committee.

Dues: The due date for payment of our dues was April 1st. This helped to get the new combination out to you before you wanted to launch your boat. Members with docks in the common areas lose them if their dues are not paid by April 1st. In fact, docks (in the common areas) of members whose dues were still unpaid on April 30 may have already been re-assigned to someone else on our waiting list. Ray Brimmer at 231-937-7946 is the board member to contact about docks in the common areas.


Members with unpaid dues and renters do not have access to any common areas.

<u>EVERY</u> boat must be registered with the state before being used on public or private lakes. Everyone that attended an annual meeting agreed that we want the marine patrol out on our lake.

Did you know?

You can access this newsletter on our website at www.indianlakes.org and it also can be delivered via e-mail. It would be much less costly to phase out the mailing of the newsletter altogether, but many of our community members are not able to receive e-mails. We currently print out over 450 copies. Stamps and the printing of the newsletter (in black and white) costs over \$500.00 each time the newsletter goes out. Smoke Signals can be e-mailed to members – as has been requested by many. E-mails sent with the "BCC:" process do not reveal other recipients' e-mail addresses. Members who would like Smoke Signals via e-mail can e-mail a note to info@indianlakes.org requesting that their newsletters be e-mailed to them – newsletters that are e-mailed are in color. The board at their October 2010 meeting voted to increase the number of issues of Smoke Signals from 3 to 4 times yearly. Two issues will be mailed and two issues will only be posted on our website and e-mailed to members whose e-mail address we have on file. Lake members who do not have internet access are welcome to pick up their copy of Smoke Signals at the office.

Member Signs:

Signs that are posted for parties, garage sales, etc., should be taken them down the day after the event is done. There are three posts at the entrance and one at the pavilion (corner of Apache Trail and Cheyenne Drive) for member signs. The road signs at the corner of Indian Shores Drive and Apache Trail (Indian Lake signs that tell which direction the different streets are) are not for member signs.

PLM (website www.plmcorp.net) mailed out a notice the first week of May to LSA members about the tentative water treatment schedule for this year.

The notice that LSA members received from PLM contained the following statement.

"DEQ permitting restriction, national holidays, and/or weather conditions may influence the timing of treatments throughout the 2011 season. PLM treats each lake according to a schedule or season plan, established with the cooperation of your lake association, lake board, or residents on the lake. The treatment schedule is approximate. Please watch your shoreline for the posting of the 8.5 x 11 inch, yellow or green signs. The signs will indicate the date of the treatment, the product used, and any restrictions on the use of treated water for swimming, watering lawns, etc."
