Please see the attached article relating to the **Redear Sunfish.** The Redear Sunfish have earned the nickname "Shellcrackers" due to their appetite for eating snails.

Please remember to "CATCH and RELEASE" the Redear Sunfish for another two to three years. This will allow the fish to grow, multiply, and continue to eat the snails in the lake which has been a problem for the past few years.

LAKE LEVEL:

The lake level is currently four inches from overflow and six inches from court level. Court level is the term for the "normal level" of the lake.




PIEZOMETERS:



The piezometers that were discussed in the last newsletter have been put in place around the lake to monitor the water flow through the sand.

PUMPS:

Steve Pritchard, John Westveer, and Don Cooper met with Fishbeck, Thompson, Carr, and Huber Engineering Group and it was determined that neither well will be able to pump at maximum capacity due to a buildup underground and around the filter that encases the pump.



- 1. Pump #1 will not have any work performed at this time. It is presently pumping at 500 gallons per minute.
- 2. Pump #2 the back pump will have a smaller pump inserted into the newly refurbished well. It will also be pumping at 500 gallons per minute.
- 3. It is imperative that both pumps and wells have a maintenance program to maintain maximum efficiency and longevity. This will be put in place and was recommended by the engineering group.
- 4. It was determined that the pump was damaged by drawing in air. Remember DO NOT TOUCH THE PUMPS. Any unsupervised small adjustment of the wheel will cause damage resulting in costs that could rise to \$93,000 if a new pump needs to be installed.
- 5. Due to the fact that each pump will only be able to pump at 500 gallons per minute, it is necessary to install a **third pump.** This will not occur until next year due to funding.

BERM WALKWAY:

The berm walkway project has been put on hold until certain property issues can be resolved.

WEED KILL:

Due to State budget cuts and the ever-rising costs of the economy, we will see an increase for the weed kill and **permit/fee**. The permit/fee has been significantly increased this year.

PAVILION RENOVATION:



Dave VanDam will be spearheading the pavilion renovation project. This year, due to funding, we will be finishing off the pavilion with a warming kitchen only and a bathroom. Future expansion will occur in the years to come.

The attorney has completed the revision and the Board met for final proof of the bylaws. After this meeting, Steve Pritchard met with the attorney to discuss the subject in further detail.

All members will soon be receiving a copy of the proposed bylaws for review. This will be in the near future, however, is dependent upon the lawyer's revision time.
