VOTE RESULTS

All four proposals passed with flying colors. Results are detailed below:

Proposal One: 177 YES to 26 NO
Proposal Two: 150 YES to 53 NO
Proposal Three: 152 YES to 49 NO
Proposal Four: 184 YES to 16 NO

The purpose of the vote was to clarify the original intent of the by-laws and Covenants and restrictions.

It took two votes to accomplish a legal vote for the sole reason that not enough votes were returned on the first llot. We must receive 60% of the property owners to return their ballot to obtain a quorum. If this amount is not received, no matter the vote's tally, it is invalid. Therefore the second vote needed to be conducted. This vote, required by the rules and regulations of the lake, needed to be conducted within 30 days of the previous vote's due date. We did receive the required proportion of votes on this second mailing. These rewordings make the bylaws and covenants & restrictions easier to understand.

WEED KILL

We plan to treat the whole lake June 10! Because we will be concentrating on the Eurasian Mill foil, you can not swim or fish for 1 day. We are sorry for the inconvenience. The mill foil was especially bad at the end of last summer. A two year cyclic pattern has developed. Therefore, this year Mill foil will be the concentration. We will of course be treating the every year broad leaf weeds and algae.

Mill foil is especially vigilant because it is one of the few weeds that can re-root itself when cut. When power hoats, or even swimmers break off a branch of this plant, can re-root and propagate.

The weed kill will have no long term detrimental effects on the fish.

We will be using the same supplier, Pinecrest Ind., again this year. We are developing an effective and efficient relationship. He is very knowledgeable and fair with his pricing.

BOATS AT THE PARK

We have been receiving some complaints, so we will ave to clarify the rules for all to understand. All docks will be maintained. They will be marked with the owners name and be of acceptable appearance. Your own insurance covers the liability. If a dock is not maintained or is a safety hazard, you will be contacted and given one week to fix. If it is not fixed it will be removed.

Boats must be kept off he grass at all times. No boat shall be overturned on the park grass, nor shall any ropes or posts be placed on shore where it will affect the park maintenance and mowing. We can not afford to pay the mowing company to move your boat weekly etc. Of course, all boats at the parks will be stickered,

No boat trailers, except when attached to a vehicle, will be left at a park. If it is, we will have to consider it abandoned and have it towed away at the owner's expense.

Please, these rules are not to infringe on your lake enjoyment, but rather insure everyone enjoyment of the park while offering backlot owner's convenient access.

Again, if you are or would like to keep your boat at a park, contact a board member immediately. Space is limited but we will find room for all.

We acknowledge boats are expensive and are most people's pride and joy so we tried picking a sticker that was not obtrusive. It will be weather proof 3x2 inch yellow rectangle with black lettering. Each boat will be numbered.

BOATING REMINDERS:

Boating under the influence of alcohol is not only stupid and dangerous it is against the law.

If you believe there is a drunk driver on the lake -- call the police. The rules on water are just as strict as they are on the road. The police will await their arrival on shore. At the minimum they can receive "under the influence" to the maximum of confiscating the boat.

Don't be a coward -- if you see a problem report it! We all need to work together to make the lake a safe place to live and play.

It has been brought to the board's attention that there have been numerous fisherman/skier encounters. If a fisherman throws a lure at a skier it is assault and can be prosecuted as such. If they "Catch" the skier, it is battery! Be careful it is much easier to talk it out on shore than in jail or the court room. If you experience either skier harassment or fisherman harassment -- call the cops! As the lake gets busier we can have no tolerance for selfishness and stupidity. Lets work together and get along to enjoy the lake to the fullest!

Finally, a review of the boating hours. Before 11:00 a.m., and after 8:30 p.m., is **NO WAKE TIME**. (Fishermen -- you can not zoom to the other side of the lake during this time, please acknowledge the no wake rule.) Between 11:00 & 8:30, ski and play to your heart's content.

ROADS

Our roads are the pits — literally! We know it but they are not governed by the lake. They are governed by the township and the county road commission. They have an annual budget of approximately \$30,000. It takes \$30,000 to pave one mile of road That does not include the continuous cost of fixing the pot holes. There was a millage increase voted on last November that will increase their budget by one mill (after this November by approximately \$30,000, to a grand total of \$60,000

Why can't we get satisfaction? The sole reason is they don't have the money. They say they are barely maintaining the roads as they are, much less improving them. As for gravel roads, they only have budgeted for one brining (to reduce dust) a year!

Our Solution to the road problems is to create our on special assessment district to help fund our road project. A petition is needed with 51% of the property owner's signatures to get started. The project would consist of re-engineering all of the lake roads, ditching them for proper run off, new gravel base, then highway spec. asphalt. Again this would include every road on our lake. The assessment would have to pass by a majority vote according to our covenants and restrictions.

We would like to buy a bond, the township will support this bond. This is so we can do the whole project at one time. We foresee a 5 or 6 year tax assessment of approximately \$200 dollars a year.

The benefits would be numerous. New roads! Our cars would last longer! Our property values will increase tremendously.

We are almost to the petition stage -- if you can he contact Tim Slavens. We will need to go door to door get these signed by the end of summer.

The other major benefit would be, that it would force the local government to allot the proper amount of money to the lake yearly. We will be negotiating a formula for that amount During construction, we will also be negotiating for them to supply the gravel and the engineering, while we pay for the paving process, etc.

Again, this is tentative, we are working very hard to improve the roads because the current system of depending on the government to do it for us is r. working. We are not "making this up from scratch", but modeling it after a successful working program. It you have insight on governmental bonds, or on roads or are just interested in HELPING get them fixed please contact Tim Slavens. Again, we need to get a petition signed by 51% of the property owners (not just the people who have houses on the lake). This will be hard work but will be well worth it. Depending on whether or not we can get these petitions, will determine how far we go in the negotiating process.
