## DUES INCREASE

The board is submitting a proposal to the membership for an increase in dues from $\$ 75$ annually to $\$ 150$ per year. The benefits of the dues increase would be many.

- First the most visible result would be greater weed control. What good is the lake if we can't play in it?
- The dues increase would also allow many other benefits to its members. We could improve the Abbott Pavilion; its building progress has been stagnant for at least the past five years.
- We can increase fish, improve the parks. and have the money to enforce our bylaws and convents and restrictions.
- You have reviewed the financial statements, if you want the best weed control. we need a YES vote!
We realize that this increase looks to be quite large but remember that its only $\$ 12.50$ /month. In the big picture of life, that isn't very much for the wonderful benefits afforded to us when we live in such a paradise.


## A couple of frequently asked questions:

1) What if we don't get the dues increase how will we proceed with weed control? Due to budget constraints we will have to continue on the same lines of treatment as in the past. The only problem is we have between $\$ 15,000-\$ 17,000$ to spend. the price of chemicals is increasing so the acreage that can be treated will be deceasing.
2) What is the Lake Shores Association part of our property taxes for?
That money is assessed by the Drain Commissioner and is controlled by them. It is used to pay the electric bill of the pumps. That money does not ever enter the lake's budget.

## Watering

A friendly reminder. YOU MAY NOT PUMP WATER
FROM THE LAKE TO WATER YOUR LAWN. Every property owner pays a lot of money to maintain the |water level, please be considerate. Lawns make houses beautiful. Remember don't fertilize within 10 feet of the lake, and use your own water. The pumps work very hard to maintain the level. Please let us know of anybody pumping out of the lake

## WEED KILL PERMIT ON HOLD

Are you sick of hearing about well depths yet? We have official notification that our weed permit is on hold. We need to have our packet of information submitted immediately (if not sooner) if we hope to have the chemicals applied before JULY!

The DEQ has sent us an example packet, which also requires a diagram of every lake front house, its wellhead, and the set back from the lake, besides the well depth. This drawing doesn't need be to be elaborate - a box for the house, a line for the lake - but the two measurements are what they are looking for - distance from the lake and depth of the well.

We just spent $\$ 296.34$ at the Mid Michigan Health Department for them to dig through their files and copy all of the well drilling permits. Only about half have diagrams, NONE have the setback from the lake. Therefore WE NEED VOLUNTEERS TO WALK THE SHORE LINE OF THE WHOLE LAKE TO DIAGRAM HOUSES. PLEASE, IF YOU CAN DO YOUR STREET, CONTACT GORDON POTTER.
PLEASE MAIL YOUR'S RIGHT AWAYI WE ONLY GOT 186 COPIES OF THE 211 HOUSES.. PLEASE WE NEED YOUR HELP - USE YOUR ART SKILLS AND GET THIS INFORMATION TO US (OR PLAN ON PUTTING YOUR BOAT MOTORS IN REVERSE A LOT!)

The question was asked what actually has been treated in the past years.

| Milfoil | 20 (acres) | 25 | 21 | 2-4-D Granules |
| Mixed Weeds | 52.5 | 60 | 70 | Reward-Komeen-cygnet Plus |
| Chara Algae | 4.3 | 6 | 6 | Copper Sulfate |

(note: the lake is 360 acres - so we can only afford to treat about $25 \%$ of the lake! And this is at a reduced rate, we haven't paid for the guarantee in return for more acres treated).

Mitch Visser accepted a unaniməus nomination to the board.
Weed Control Discussed. The question was raised whether or not contact herbicides would be better than systemic - they are cheaper. Contact will be made with Pinecrest to determine the answer.

Thomas Smith volunteered to identify all lake front lots with houses on the lake plot map. This is a required part of the DEQ packet. THANKS!

Tonto dike was in jeopardy. Mr. Westveer noticed the creek was running too fast. Volunteers got a temporary hold on it with sand bags, the County was out the following day.

Finances: Dues are coming in very slowly; we need to make sure the Smoke Signals reminds everyone that only members in good standing can vote.

Collections are doing well, $65 \%$ of $\$ 5000$ has been collected.
Church is considering how payment should be made for the programming, systems support and web page. He will be submitting a proposal before summer.

Brooks to contract Robinson Septic for Port-a-Johns this summer. Cost of $\$ 225 / \mathrm{mo}$ for three.

Mr. and Mrs. Don Postma and Mr. and Mrs. Gord Potter will be representing the lake at Michigan Lakes and Streams the end of April.

Thompson to contact the Mounted Division of the Montcalm County Sheriffs Department to count the vote. (Note: They meet the second Sunday of the month). The board agreed to donate $\$ 100$ to them if they could do it. This should reduce controversy over who counts the vote.

Brooks negotiated a deal with Robinson Septic that if 6 in an area would get theirs pumped the price would drop from $\$ 125$ to $\$ 85$ ! Postma said he would help coordinate this, since he's already coordinating the Spider spraying.

## BALLOT

Remember that dues were due by APRIL. $1^{n}$, if we have collected your dues, in this mailing you should have received two envelopes. (Remember only "members in good standing" can vote - meaning dues are paid). The larger of the two is the return envelope, make sure you sign across the flap so we can be insured that it is intact upon arrival and during the counting process. The little envelope contains the ballot (below - cut it off) ONLY! There should be no names, no notes just one $\mathbf{X}$ to support or not to support the dues increase on the ballot or its envelope.

DO NOT mail any Well Depth information in these envelopes. These envelopes will be held for a 30 day period from the time of this mailing and we will hire "outsiders" to count them to avoid any controversy that we "hand picked" counters.

All well depth information and diagrams must go to PO BOX 63 . As you will note, the envelope for this vote goes to a special P.O. Box.
